(*Ord. # 06-3 Chapter IV-E*)

READ AND SIGN

ALL DUMPSTERS PLACED IN PUBLIC AREA ARE REQUIRED TO COMPLY WITH THE FOLLOWING CONDITIONS:

- 1. PLANKING OR WOOD SHEETING OF SUFFICIENT SIZE REQUIRED TO BE PLACED UNDER THE WHEELS OR ROAD CONTACT AREA TO PROTECT THE ROADWAY FROM DAMAGE
- 2. FLASHING AMBER WARNING BARRICADE-MOUNTED LIGHTS ARE REQUIRED TO BE PLACED ON THE DUMPSTER TO PROVIDE A VISUAL WARNING TO THOSE UTILIZING THE ROADWAY OR PUBLIC RIGHT- OF -WAY.
