# BOROUGH OF ELMWOOD PARK REGULAR MEETING BOARD OF HEALTH MEETING November 20, 2017 7:00 p.m.

The Regular Meeting of the Elmwood Park Board of Health for November 20, 2017 was called to order by Board Secretary Barbara Dispoto at 7:00 p.m.

Board of Health Members Levine, Marsella, Morello, McCauley and Wareka were present. Board Members Proctor and Spinelli were absent. Also present Health Inspector Michelle Delyannis, Board Secretary Barbara Dispoto and Councilman Golabek.

Now, Therefore Be Advised, that the meeting requirements for this meeting have been met by publishing an annual meeting notice in The Record and Herald News of Woodland Park and by posting such notice in the office of the Health Department and the Borough Clerk as well as in a public place within the Municipal Building, and by notifying interested citizens. Said notice was posted on December 18, 2016.

#### 1 – HEALTH INSPECTION REPORT:

- a. Monthly Inspection Report The Board reviewed the October 2017 Inspection Report.
- 2 2017 Flu Clinic Follow Up Board Secretary Barbara Dispoto reported that a total of 51 vaccines were administered between the two clinics, with the possibility of only 27 being covered by medicare. Discussion ensued as to the cost the Borough will incurred due to the low credit the borough will receive because of the low turnout of valid medicare claims. The low turnout may be a result of the convenience of obtaining flu vaccines at local pharmacies and grocery stores. The Board decided to revisit discussion as to whether or not to continue with the flu clinics prior to the summer break in 2018.
- **3 T-N-R Brochure** The Board reviewed the brochure submitted by Board Member Spinelli. The only suggestion made to change on the flier was to increase the font size of the title. Additional copies of the flier will be made for distribution to other municipal buildings.

## BOROUGH OF ELMWOOD PARK **BOARD OF HEALTH ORDINANCE # 2017-03**

AN ORDINANCE ENTITLED, "AN ORDINANCE ENABLING THE ELMWOOD PARK BOARD OF HEALTH TO CLOSE ANY BUSINESS LISTED IN ACCORDANCE WITH ORDINANCE 2015-02 WHICH FAILS TO HOLD AND MAINTAIN A VALID LICENSE TO CONDUCT BUSINESS WITHIN THE BOROUGH OF ELMWOOD PARK."

A license is required for the privilege of engaging in any business listed in Ordinance 2015-02 within the Borough of Elmwood Park. Such license fee shall be applicable to any business maintaining a permanent business location or branch office within the Borough.

Any Business engaging in any operations covered by this article that does not pay the required license within thirty-one (31) days after the fee due date, and that does not obtain the required license:

- Shall be required to immediately cease operation of the Business in the Borough until such time as the license is renewed.
- 2. Shall incur an additional penalty of two hundred fifty dollars (\$250.00).
- 3. Shall be subject to administrative and/or civil action for collection of the fee, as well as be liable for court costs, reasonable attorneys' fees, additional administrative costs incurred by the Borough as a result of collection efforts

It shall be unlawful for any person, either directly or indirectly, to conduct or carry on a business or to use in connection therewith any vehicle, premises, machine or device, in whole or in part, for which a license is required by any ordinance of this Borough without a license having first been procured therefor and kept in effect at all such times as required by this chapter or other ordinance of this Borough heretofore or hereafter adopted. It shall also be unlawful for any person, either directly or indirectly, to conduct or carry on a business in this Borough in a manner differing from any description of the business operation contained in the previously submitted license application or not consistent with the certification contained on the application for said business license.

#### **Enforcement:**

This section shall be enforced by the Elmwood Park Board of Health.

## **Effective Date:**

This section shall take effect upon final passage according to law.
