BOROUGH OF ELMWOOD PARK BOARD OF HEALTH ORDINANCE # 2017-03

AN ORDINANCE ENTITLED, "AN ORDINANCE ENABLING THE ELMWOOD PARK BOARD OF HEALTH TO CLOSE ANY BUSINESS LISTED IN ACCORDANCE WITH ORDINANCE 2015-02 WHICH FAILS TO HOLD AND MAINTAIN A VALID LICENSE TO CONDUCT BUSINESS WITHIN THE BOROUGH OF ELMWOOD PARK."

A license is required for the privilege of engaging in any business listed in Ordinance 2015-02 within the Borough of Elmwood Park. Such license fee shall be applicable to any business maintaining a permanent business location or branch office within the Borough.

Any Business engaging in any operations covered by this article that does not pay the required license within thirty-one (31) days after the fee due date, and that does not obtain the required license:

- 1. Shall be required to immediately cease operation of the Business in the Borough until such time as the license is renewed.
- 2. Shall incur an additional penalty of two hundred fifty dollars (\$250.00).
- 3. Shall be subject to administrative and/or civil action for collection of the fee, as well as be liable for court osts, reasonable attorneys' fees, additional administrative costs incurred by the Borough as a result of collection efforts

It shall be unlawful for any person, either directly or indirectly, to conduct or carry on a business or to use in connection therewith any vehicle, premises, machine or device, in whole or in part, for which a license is required by any ordinance of this Borough without a license having first been procured therefor and kept in effect at all such times as required by this chapter or other ordinance of this Borough heretofore or hereafter adopted. It shall also be unlawful for any person, either directly or indirectly, to conduct or carry on a business in this Borough in a manner differing from any description of the business operation contained in the previously submitted license application or not consistent with the certification contained on the application for said business license.

Enforcement:

This section shall be enforced by the Elmwood Park Board of Health.

Effective Date:

This section shall take effect upon final passage according to law.
