BOROUGH OF ELMWOOD PARK REGULAR MEETING BOARD OF HEALTH MEETING April 11, 2016 7:00 p.m.

The Regular Meeting of the Elmwood Park Board of Health for April 11, 2016 was called to order by Board Secretary Barbara Dispoto at 7:00 p.m.

Board of Health Members Levine, Marsella, Morrello, Proctor, Spinelli, Wareka and McCauley were present. Also present Councilman Dombrowski, Inspector Margaret Dunne and Board Secretary Barbara Dispoto.

Whereas, Chapter 231 of the Public Laws of the State of New Jersey requires at the commencement of every meeting a Statement of Compliance be read by the presiding officer.

Now, Therefore Be Advised, that the meeting requirements for this meeting have been met by publishing an annual meeting notice in The Record and Herald News of Woodland Park and by posting such notice in the office of the Health Department and the Borough Clerk as well as in a public place within the Municipal Building, and by notifying interested citizens. Said notice was posted on January 4, 2016.

Regular Meeting Agenda Items:

1 – HEALTH INSPECTION REPORT:

- a. Monthly Status Report The Board reviewed the status report for the month of March. Discussion ensued as to the inspections of church and veteran establishments. Mrs. Dunne stated that halls don't let other groups that rents the hall utilize their kitchens. Discussion ensued to the complaint regarding Taco Bell. An inspection was made following the complaint and the restaurant was compliant with the preparation and the storage of the foods. Expiration dates were also checked and no issues were found. Discussion ensued to the planned event, Taste of Elmwood Park, which is being sponsored by the Centennial Committee. Councilman Dombrowski inquired about any changes pertaining to the Zika virus. Mrs. Dunne stated the best practice to try and control the mosquito population is to remove any standing water.
- 2 Child Health Conference with the Borough of Wallington Mrs. Dispoto stated a letter was sent to the Administrator of Wallington to enter into an agreement for Child Health Conference. She further stated that the request was taken to a meeting of the Governing Body of Wallington. Mrs. Dispoto stated she will report any progress to the Board at the next meeting.
- 3 Food Handlers Certification Training Dates through the County Mrs. Dispoto stated she call the provider of ServSafe Certification that was discussed at the March meeting. Unfortunately the provider does not offer Food Handlers courses. A list of dates the County provides the Food Handlers course was distributed to the Board members and the Elmwood Park Little League. Mr. Work, a representative of the Little League stated that he will follow through

with the certifications for the Little League. The Softball program only handles packaged food therefore a Food Handlers certification is not needed. Mrs. Dispoto also stated that the Recreation Department monitors the certifications for the Recreation sport programs.

4 – Update regarding Dog Licensing Issues discussed at the March 14, 2016 Meeting – Mrs. Dispoto stated the late fee and the bounced check that was discussed at the last meeting has been satisfied.

5 – ORDINANCES:

a. **2016 Salary Ordinance** – Mrs. Dispoto discussed the drafting of two salary ordinances. She stated that based on the Executive Session minutes, an increase was discussed for two of the three positions covered by the salary ordinance. Draft #1 indicates a 2% increase for the Board Secretary and Deputy Registrar positions. Draft #2 indicates a 2% increase for the Board Secretary, Registrar and Deputy Registrar positions. After some discussion, draft #2 was selected to be used for the first reading.
