BOROUGH OF ELMWOOD PARK REGULAR MEETING BOARD OF HEALTH MEETING September 12, 2016 7:00 p.m.

The Regular Meeting of the Elmwood Park Board of Health for September 12, 2016 was called to order by Board Secretary Barbara Dispoto at 7:00 p.m.

Board of Health Members Levine, Marsella, Morrello, Proctor, Spinelli, Wareka and Mc Cauley were present. Also present Councilman Dombrowski, Inspector Margaret Dunne and Board Secretary Barbara Dispoto.

Whereas, Chapter 231 of the Public Laws of the State of New Jersey requires at the commencement of every meeting a Statement of Compliance be read by the presiding officer.

Now, Therefore Be Advised, that the meeting requirements for this meeting have been met by publishing an annual meeting notice in The Record and Herald News of Woodland Park and by posting such notice in the office of the Health Department and the Borough Clerk as well as in a public place within the Municipal Building, and by notifying interested citizens. Said notice was posted on January 4, 2016.

Regular Meeting Agenda Items:

1 – HEALTH INSPECTION REPORT:

- a. Monthly Status Report June, July & August 2016 Health Inspector Dunn stated quite a few dog on human bite incidents took place. She also discussed a 45 day confinement that was issued to a Borough dog which had an altercation with a raccoon. The dog was taken to the vet and received vaccines and the vet did not find any bleeding or lacerations. However, because it was a dog on raccoon incident, a 45 day confinement is required. Discussion ensued to a complaint of cockroaches from Elmwood Terrace apartments. Mrs. Dispoto stated the complex was sending exterminators to the apartment, however the complainant was directed to do some preparation for the exterminator and did not follow through which is slowing down the process to exterminate. The exterminator has since returned to the apartment to perform his extermination. Health Inspector Dunne discussed the inspection schedule pertaining to the different risk types.
- 2 2016 Flu Clinics have been scheduled for October 3, 2016 & October 18, 2016 Board Secretary stated there are two flu clinics scheduled. The first will be held on October 3, 2016 from 6:00 a.m. until 7:00 p.m. in the Municipal Building. The second clinic will be held on October 18, 2016 from 10:00 a.m. to 11:00 a.m. at the Senior Center. Vaccines are free to residents that have Medicare/Medicaid, Borough employees and Board of Health members. There will be a \$25 charge to anyone who does not fall under the groups stated above.

- 3 Letter from Bergen County Health Department regarding local animal licensing and rabies control No discussion ensued as the Borough currently abides by the requirements stated in the letter.
- 4 Literature received from Partnership for Maternal & Child Health Board Secretary Dispoto discussed the brochures supplied to the Board members. After some discussion it was decided Mrs. Dispoto would invite Ms. Pleasant to the October Board meeting to discuss the program.
- 5 New and Existing businesses and licensing Mrs. Dispoto discussed how facebook has alerted the Health Department to two businesses that did not file for permits/licenses to do business within the Borough. She stated when a business does not have the permit/license, a letter is sent to the business along with the application that must be returned within 10 days. Discussion ensued as to how new businesses should be alerted that an application must be filed with the Health Department.
