# BOROUGH OF ELMWOOD PARK REGULAR MEETING BOARD OF HEALTH MEETING March 13, 2017 7:00 p.m.

The Regular Meeting of the Elmwood Park Board of Health for March 13, 2017 was called to order by Board Secretary Barbara Dispoto at 7:00 p.m.

Board of Health Members Levine, Marsella, Morello, Proctor, Wareka and McCauley were present. Board Member Spinelli was absent due to a work commitment. Also present Councilman Golabek, Health Inspector Margaret Dunne and Board Secretary Barbara Dispoto.

Discussion then ensued as to whether hair nets are required. Inspector Dunne stated that hair nets are no longer required however there is a stipulation that hair should be retrained somehow to prevent hair getting into food.

a. Re-adopt Board of Health By-Laws for 2017 – Board Secretary stated that at the last board meeting, Member Wareka stated that no changes were needed to the by-laws. Mrs. Dispoto represented all the Board members with a copy of the by-law to be re-adopted.
