BOROUGH OF ELMWOOD PARK WORK MEETING

May 10, 2018 7:00 p.m.

The Work Meeting of the Elmwood Park Mayor and Council for May 10, 2018 was called to order by Municipal Clerk Keith Kazmark at 7:01 p.m. The Statement of compliance was read.

Council Members Balistrieri, Chirdo, Giandomenico (7:09 arrival), Pellegrine and Golabek were present. Councilman Dombrowski was absent. Also present were Mayor Francesco A. Caramagna, Municipal Clerk Keith Kazmark and Borough Attorney Giuseppe Randazzo.

Jeff Frietag, Hillman Drive, inquired about the 4-way stop signs near the schools and as to whether they are legal. He further stated posting 4-way stops throughout town if the purpose of the installation of signs are a matter of safety.

It was stated that attempts to create a task force were unsuccessful due to the lack of volunteers. It was further stated that funding that EP Takes Action will be soon be coming to an end. Mr. Kazmark discussed a councilmember becoming a liaison to the Stigma Free Task Force and reach out to various organizations for a liaison to represent them on the task force. He further discussed other municipalities that helped Woodland Park to create their task force and he could forward those contacts so they can also help Elmwood Park.

Councilwoman Balistrieri reported on the new name signs on Mola Boulevard on Market Street and Linden Avenue. The State will be replacing the signs on Route 4 & Route 46. She discussed the need for a new truck for the Department of Public Works.

Councilman Chirdo discussed a recent ordinance committee meeting in which rent control was discussed.

Councilwoman Giandomenico discussed a meeting with Chief Pais and a possible incentive program.

Councilwoman Pellegrine discussed the Police Department Meet & Greet that was held. She spoke on the painting of yellow curbs and 4-way stop signs. She further discussed the upcoming interviews of potential police officers. She discussed a prior Chamber of Commerce meeting that she attended. Councilwoman Pellegrine discussed a recent forum that was held by

the Board of Health which had Representatives from Bergen County Animal Shelter/Animal Control to inform residents on the local wildlife and answer questions. She stated the spring rabies clinic will be on May 17, 2018. She discussed a Resident Assistance Program that she is spearheading.

He also discussed the parking issues and his desire for the borough to have permit parking. He further discussed the burden on the infrastructure from replacing single family homes with two family homes.

Denise Inqui, Falmouth Avenue, discussed the stop signs along Spiedel Avenue, the Ambulance Corps having more coverage due to summer break for college students.

Doris Wechtler, Philip Avenue, inquired as to the completion date for the repairs to the spray park.

Keith Work, Gilbert Avenue, inquired about the Veterans Memorial committee and the hiring of a new employee for the Recreation Department.
