WHEREAS, the Mayor and Council have been made aware of certain adjustments to the designation of positions as well as designation and adjustments to compensation thereof that are not contained or addressed by the Ordinance; and

WHEREAS, the Mayor and Council wish to correct same by including designation of positions together with adjusting and setting forth commensurable salary and or hourly rate for particular employee(s) effected by such inconsistency and maintain a sense of just and fair treatment; and

WHEREAS, the Mayor and Council have acknowledged and determined that said inconsistency should be addressed by way of amended to the ordinance.

NOW THEREFORE BE IT ORDAINED by the Mayor and Council of the Borough of Elmwood Park, County of Bergen, and State of New Jersey that the Salary Ordinance is hereby amended as follows:

SECTION 1: that SECTION II entitled "Department Head & Non-Union Employees" more specifically the salary for the Court Administrator contained in the chart under paragraph 1 shall be amended to read \$69,857.57.

SECTION 2: that SECTION II entitled "Department Head & Non-Union Employees" more specifically the chart under paragraph 1 shall be amended to include a new designation of Construction Official/Building Subcode Official with a salary of \$40.80/Hr.

SECTION 3: that SECTION II entitled "Department Head & Non-Union Employees" more specifically the salary for the Recreation Director contained in the chart under paragraph 1 shall be amended to read \$67,000.00.

SECTION 4: that SECTION III entitled "Part-Time Employees" more specifically the chart under paragraph 1 shall be amended to include a new designation of Zoning Official with a designated salary of \$2,500.00

SECTION 5: that in the event any section, part or provision of this amended Ordinance shall be held unconstitutional or invalid by any Court, such holding shall not affect the validity of this rest of the amended Ordinance, or any remaining part of this amended Ordinance other than the part held unconstitutional or invalid.

SECTION 6: that all ordinances or parts thereof, which are inconsistent with the provisions of this amendment, are hereby repealed to the extent of their inconsistencies.

WHEREAS, the Mayor and Council have determined that there exists a need to review the wording set forth in said section of the Borough Ordinance of Elmwood Park and thereby promoting and maximizing the service rendered and to be more efficient in its operation. And

WHEREAS, the Mayor and council wish to address the period of appointment of the Director of Parks and Recreation.

BE IT ORDAINED by the Mayor and Council of the Borough of Elmwood Park, County of Bergen, and State of New Jersey as follows:

SECTION 1: Chapter II of the code of the borough of Elmwood Park titled "administration" more specifically Article III section 2-33.2b titled "Appointment; Term" shall be and is hereby amended and replaced with the following language:

"The Recreation and Parks Director shall be appointed by the Mayor with the advice and consent of the Council, and the term of the office of the Director shall be at the pleasure of the Mayor and Council. Any vacancy in this office shall be filled by appointment of the Mayor and Council."

BE IT FURTHER ORDAINED that all of the remaining parts of the Ordinance relating to the extent that same are not inconsistent with this Ordinance shall remain in full force and effect until modified or repealed pursuant to law. All Ordinances or parts of Ordinances inconsistent herewith are hereby repealed as to such inconsistencies.

SECTION 3: Invalid Provisions

If any section, subsection, sentence, clause, or phrase of this Ordinance is for any reason held to be unconstitutional or invalid, such decision shall not affect the remaining portions of this Ordinance.

ACCEPTING A SUBAWARD GRANT FROM THE FEDERAL OFFICE OF JUVENILE JUSTICE AND DELINQUENCY PREVENTION PROVIDED TO THE STATE OF NEW JERSEY DEPARTMENT OF LAW AND PUBLIC SAFETY.

WHEREAS, on April 1, 2020 the Police Department of the Borough of Elmwood Park applied for a Federal grant, under the provisions of the Juvenile and Delinquency Prevention Act (JJDP Act) of 1974, 42 USC sec 5631-5633, under the grant name of FY2016 Title II, awarded to the Department of Law and Public Safety, under Federal Award Identification number 2016-JF-FX-0039, who has sub awarded to the Elmwood Park Police Department as a subrecipient for the specific purpose as set forth in the application for the grant to expand and provide the Summer Expansion Program for the Junior Police Academy Program, a not for profit program, implemented on a yearly basis,; and

WHEREAS, the application having been approved and an awarded of \$9,000.00 from the NJ Department of Law and Public Safety for a Summer Expansion Program, for the Junior Police Academy, for the sub award period for the summer of 2020 was granted without matching funds; and

WHEREAS, the purpose of the grant is designed and implemented for the summer expansion program, more specifically to be used for the Junior Police Academy program of the Borough of Elmwood Park, which initiative is to promote and restore a favorable climate between the youth of our Borough and the Police Department and at the same time to improve the quality of life for the citizens, residents and businesses of this neighborhood; and

WHEREAS, as a condition of the grant, requires that the Borough of Elmwood Park on behalf of the Elmwood Park Police Department as a not for profit organization to authorize the acceptance of the subaward grant and that the acceptance of the grant is for the particular purpose as described on the application as submitted;

NOW, THEREFORE, BE IT RESOLVED that the Borough Council of the Borough of Elmwood Park does hereby "authorize to accept " and does hereby accept the Subaward grant of the sum of \$9,000.00 and further certifies that the sum of the subaward will be and is hereby accepted for the purpose so described in the application and will comply with any and all guidelines and requirements set forth with the award of the particular grant. The Mayor and Council further authorize the submission of any and all documents to the New Jersey Department of Law and Public Safety; and

BE IT FURTHER RESOLVED that the Mayor and Council does hereby authorize the expenditure of said funds in accordance with this subaward and does acknowledge that it is subject to the requirements set forth in the appropriate Federal Regulations, the General Conditions for subawards promulgated by the Department of Law and Public Safety, all applicable Statutes of the State of New Jersey and the requirements of the State of New Jersey for State and Local financial accounting including the filing of single audits as required under 2 C.F.R. Part 200, Subpart F, Audit Requirements (2 C.F.R. §200.500, and/or State Circular Letters 15-08-0MB and 07-0S-0MB (if applicable).
